## PROMOTIONAL GAMES AND HOW TO PLAY

- A PUNCH A BUNCH ${ }^{\text {TM }}$ board will appear with twenty-five (25) available punch board slots.

- SECRET XTM How to Play:
- A SECRET XTM board will appear and the player will be prompted to place three (3) Xs on the board, choosing from all available spaces.
